GENERAL TERMS AND CONDITIONS AND PERSONAL GUARANTY

1. Statements are sent on the first (1st) day of each month.
2. All invoices become payable in full on the “due date” as stated thereon and if not paid by the aforementioned “due date” they are considered past due.
3. A service charge of 1.5% per month will be added to all amounts billed if not paid by the end of the month.
4. No additional credit will be extended to past due accounts unless satisfactory arrangements are made.
5. If Robinson Oil Company is forced to pursue enforcement of this instrument, Applicant agrees to pay all costs incurred by Robinson Oil Company in its collection efforts, including all court costs, filing fees, and reasonable attorney fees.
6. Applicant shall provide Robinson Oil Company with prompt written notice of any change in Applicant’s name, address, ownership, or form of business entity.

IN CONSIDERATION of credit given and to be given from time to time by Robinson Oil Company, the undersigned hereby unconditionally, jointly and severally guarantee the payment of any and all amounts due Robinson Oil Company. It is understood that this guaranty shall be a continuing and irrevocable guaranty of payment of any and all indebtedness of Applicant. The undersigned expressly waive notice of acceptance of this Guaranty, presentment for payment, notice of default, notice of non-payment, and protests and consents to any extension of time of payment granted by Robinson Oil Company. The undersigned hereby agree and consent that Robinson Oil Company may accelerate the time of payment stated above, make additional advances or extension of credit to Applicant, and change the rate of interest applied to those amounts of credit extended to Applicant. The undersigned further waive and agree not to assert or take advantage of: any right to require Robinson Oil Company to proceed against Applicant before proceeding against the undersigned; and, any defense that may arise by reason of incapacity, lack of authority, death or disability of any person. The undersigned shall pay all reasonable attorney fees, courts costs and other expenses incurred by Robinson Oil Company in connection with enforcing any obligations of the undersigned to this Guaranty.
